WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 Dr. Zakir Husain College Society, Ilayangudi-630702, Tamilnadu has submitted an application to the Southern Regional Committee of NCTE in the name of Dr. Zakir Husain College of Education, Paramakudi Road, Ilayangudi Village, Ilayangudi Post & Taluk, Sivagangal District-630702, Tamilnadu for seeking grant of recognition for conducting B.Ed course on-line on 29.10.2009.

And whereas, application was processed and deficiency letter was issued to the institution on 22.12.2009. The institution submitted its written representation on 01.03.2010, which was considered by SRC in its 190<sup>th</sup> meeting held on 29-30<sup>th</sup> March, 2010 and the Committee decided to reject the application.

And whereas, the application was rejected vide order no. F.SRC/NCTE/M.Ed/2010/18632 dated. 03.05.2010. Aggrieved by the rejection order, the institution filed appeal under section 18 of NCTE Act, before the Appellate Authority, NCTE, New Delhi. The Appellate Authority vide its order dated 19.07.2010 remanded back the case to SRC for necessary action.

And whereas, SRC considered the appeal order in its 195<sup>th</sup> meeting held on 17<sup>th</sup>-18<sup>th</sup> August 2010 and the committee decided to call for Minority Status Certificate in the name of the proposed college from the Competent Authority in order to take a final decision in the matter.

And whereas, a letter was issued to the institution on 22.09.2010 to submit the same. The institution vide its letter dated 26.10.2010 has submitted declaration dt.25.10.2010 on Rs.20/- stamp paper which is placed in file. They have however not submitted minority status certificate in the name of proposed college from the competent authority.

And whereas, SRC considered the matter in its 198<sup>th</sup> meeting held on 24<sup>th</sup>-26<sup>th</sup> November 2010 and decided to cause inspection of the institution Under Section 14/15 of NCTE Act. Accordingly inspection of the institution was conducted on 18.02.2011.

And whereas, the Committee in its 202<sup>nd</sup> meeting held on 14<sup>th</sup>-15<sup>th</sup> March 2011 considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve Show cause Notice under Section 17 of NCTE Act.

And whereas, accordingly, a show cause notice was issued to the institution on 12.04.2011 the institution submitted in its reply on 09.05.2011.

And whereas, the Committee in its 207<sup>th</sup> meeting held on 23<sup>rd</sup> June, 2011 considered the reply of the institution dated 09.05.2011 and decided to issue letter of intent prior to grant of recognition under clause 7(9) of the NCTE regulation, the Regional Committee decided to issue Letter of Intent for grant of recognition to B.Ed course of **one year duration** with an annual intake of **100**(One hundred only)(one unit) from the **academic year 2011-12** subject to the appointment of qualified staff through duly constituted selection committee (within 10 days) as per the Norms of NCTE/State Government/Affiliating University and be given effect before the commencement of the academic session.

Further, committee resolved/decided that the institution be directed to submit a notarized undertaking:

- (i) Declaring themselves as minority trust and minority institution proposed to be established.
- (ii) Giving an undertaking that the management shall produce valid minority certificate from the notified authority of the respective State Government on or before 31<sup>st</sup> March, 2012 failing which, the institutions shall be de-recognized automatically without any further notice and that such institutions shall make no further admission thereafter.

And WHEREAS, a letter of intent was issued to the institution on 31.05.2011 the committee in its 208<sup>th</sup> meeting held on 13<sup>th</sup>-14<sup>th</sup> July, 2011 considered the reply for letter of intent and other documents submitted by the institution and decided to issue formal recognition order.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Dr. Zakir Husain College of Education, Paramakudi Road, Ilayangudi Village, Ilayangudi Post & Taluk, Sivagangai District-630702, Tamilnadu or conducting B.Ed Course of one year duration with an annual intake of 100(Hundred) students from the academic session 2011-2012 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2007 subject, to fulfillment of the following conditions:

- I The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- II The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- IV The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- V The institution shall declare themselves as minority trust and minority institution proposed to be established.
- VI The institution/Management shall produce valid minority certificate from the notified authority of the respective State Government on or before 31<sup>st</sup> March, 2012, failing which, the institutions shall be de-recognized automatically without any further notice and that such institutions shall make no further admission thereafter.


Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution, **Dr. Zakir Husain College of Education, Paramakudi Road, Ilayangudi Village, Post & Taluk, Sivagangai District-630702, Tamilnadu** has by affidavit consented to come under New Regulations and sought for two basic units in **B.Ed** which require additional facilities

3. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017

4. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to **Dr. Zakir Husain College of Education, Paramakudi Road, Ilayangudi Village, Post & Taluk, Sivagangai District-630702, Tamilnadu** for conducting **B.Ed** programme of two years duration with an annual intake of **100** students each for two basic units from the academic session **2015-16** subject to fulfilment of the conditions mentioned herein before 31.10.2015

5. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.



*On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution **Dr. Zakir Husain College of Education, K. Idayavalasai Village, Southern Ilayangudi, S. No. 218/2, 218/4, 219/5, Ilayangudi Town Panchayat, Sivagangai Dist, Tamilnadu- 630702** for B.Ed programme for 2 basic units of 50 students in each unit.*

4. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Dr. Zakir Husain College of Education, Sy. No. 218/2, 218/4, 219/5, K.
